The Michigan State Bar Foundation provides leadership and grants to improve access for all to the justice system, including support for civil legal aid for low-income households, law-related education, and conflict resolution.

CIVIL LEGAL AID HELPS ASSURE FAIRNESS IN THE JUSTICE SYSTEM

Nonprofit civil legal aid organizations provide access to legal help for low-income people to help protect their livelihoods, their health, and their families.

ENSURING HOUSING STABILITY



A father was laid off due to the COVID pandemic shutdown. As a result, he could not cover the monthly rent or utilities. He contacted legal aid for help when his landlord threatened to evict his family. A legal aid attorney prevented the eviction order from being entered in court and connected the family to the Eviction Diversion Program. The program was able to pay the back rent and the utilities. The family is safe in their home without the threat of being homeless.

CIVIL LEGAL AID FULFILLS A CRITICAL NEED AT A LOW COST

Michigan's nonprofit civil legal aid programs coordinate through a statewide infrastructure that provides a continuum of services - including, an informational website, a hotline staffed by attorneys to provide advice, and full representation by an attorney - so individuals can access the level of assistance they need to solve their problem. Thirty-five staffed offices provide civil legal aid in every county in the state.

- Michigan Legal Help Program An online clearinghouse providing information on legal topics, links to legal forms and other self-help resources. The website also includes a triage and referral function through the Guide to Legal Help, a step by step tool connecting people to the right resources, including referrals to attorneys or a legal aid organization. In 2020, MLH had an average of 127,706 visits per week to the website.
- **Counsel and Advocacy Law Line** A statewide attorney staffed hotline for low-income individuals and older adults. CALL attorneys advise on housing, public benefits, consumer law, domestic relations, unemployment benefits and other civil matters. CALL provides tailored advice to individuals who call for help and direct referrals to legal aid organizations. In 2020, CALL helped 17,409 individuals.
- Nonprofit civil legal aid organizations When a case is more complex or an attorney is needed, legal aid organizations provide representation. The legal aid programs in Michigan are integrated within their communities and work closely with community partners to identify clients who need help. Legal aid programs also provide the infrastructure to help private lawyers provide pro bono legal assistance to low-income clients. In 2020, pro bono attorneys provided 12,447 hours of pro bono services through the Foundation's annual grantees.



ASSURING SAFETY FOR FAMILIES

"Without legal aid, I would not have known what to do while going through my custody case. As a single mother, I could not afford legal representation for myself, but legal aid guided me through the process every step of the way. My attorney was kind and patient with me and always believed in my fight. Coming from a relationship where domestic violence occurred, I never felt like I had to over

> explain myself. She remained sensitive to mine and my child's trauma and supportive of our recovery. Without legal aid I don't feel the outcome would have gone the way it did and I am grateful for their help." - Legal Aid Client

ADMINISTRATIVE JUSTICE GRANTS



CIVIL LEGAL AID PROVIDES CRITICAL CONSTITUENT SERVICES

Michigan State Bar Foundation grantees help constituents who live in households with annual incomes at or below 125 percent of the federal poverty guidelines (\$32,750 for a family of four). Civil legal aid helps thousands of individuals each year, including veterans and military families, homeowners and renters, families with children, individuals who are ill or disabled, victims of domestic violence, and older adults.

GENDER OF CLIENTS SERVED




PROTECTING VETERANS' RIGHTS



A veteran with a disability lost his job due to health reasons and had fallen behind on his condominium association fees. He attended a mediation, without the assistance of a lawyer, and agreed to enter a repayment agreement and transferred the deed to his home

to the condo association. After making payments, he mistakenly sent in a check that was returned as non-sufficient funds. Though he quickly issued a new repayment, the condominium association filed an eviction case against him. He requested help and Legal Aid was able to help negotiate a settlement to restore ownership of his condo. The veteran was able to catch up on his past due fees and keep his home.

FUNDING SOURCES

- Interest on Lawyers' Trust Accounts (IOLTA) - Attorneys are required to hold deposits made on behalf of clients in a trust account and when that amount is short-term or nominal, they pool it into one account. The interest generated by these accounts is remitted to the Foundation to help with grantmaking.
- Filing Fees The state legislature assigned MSBF the responsibility of administering filing-fee funds for distribution to legal aid programs (MCLA 600.1485).
- Access to Justice Campaign A collaborative centralized campaign, in partnership with the State Bar of Michigan, administered by the Foundation, to raise money from the legal community for 15 civil legal aid organizations throughout Michigan.
- Other The Foundation also receives and manages other donations, such as a Fellows program, cy pres awards, and special projects in partnership with state agencies, such as the Eviction Diversion Program.


