

# 2022 Remittance Report Instructions

The Michigan State Bar Foundation is providing the following instructions for submitting financial institution IOLTA remittance reports. Please direct any questions to Kailyn Delmotte at 517-346-6404 or ioltareport@msbf.org.

## **Remittance Reports**

A single electronic remittance report for all accounts at the bank must be submitted for each remittance period (monthly or quarterly), whether or not interest has been earned on those accounts. Banks should use IOLTA's pre-formatted Excel template. The template (which includes a sample report) is available on our website at <u>www.msbf.org/remittanceupload/</u>. Please contact the Foundation with any questions on file format.

The remittance report file name should include the bank name and indicate the period covered by the report (**bank\_name\_remittanceperiod.xlsx**). Examples:

FirstNationalBank\_jan2020.xlxs CommunityNationalBank\_3Q2020.xlsx Webster1stbank\_apr-jun20.xlsx

## Submitting a Remittance Report

## a. Register to Use the Remittance Upload System (RUS)

To utilize the IOLTA remittance upload system (RUS), participating bank users first must register.

**Note**: Each participating bank may have a maximum of three users. Each user must utilize a separate email address. To delete a user or reset a password, submit a request by email to the Foundation at <u>ioltareport@msbf.org</u>.

From the Remittance Upload System page of the MSBF website (www.msbf.org/remittanceupload/) click the SECURE - Remittance Upload red button:

- Select your banking institution from the drop down menu and complete the form, including creating a new password. (Your email address and password will be used to access RUS for all future submissions.) Click the "I'm not a robot" checkbox and click Submit.
- If successful, the following message will appear:

Thank you for your registration! You will receive an email containing a link to verify the email address you provided. Please verify your email address to activate your account.

• Within a few minutes, you will receive an email from noreply@msbfrus.org. Open the email and click (as shown below) to complete the registration process. If you do not receive the confirmation email please check your junk or spam email folders.

- To ensure delivery of the registration email, please record the domain "msbfrus.org" as a safe sender in your email system. (This may require contacting your IT department for assistance).
- Clicking the link <u>click here</u> in the email (example below) will open a new browser window with a message confirming that your email address has been verified and that the registration process is complete.

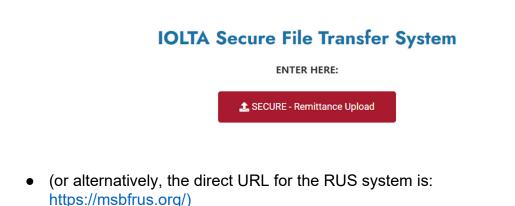

## b. Uploading Remittance Files

After registering, visit RUS to upload a **Remittance File**, an **Adjustment File**, or a **Closed Account File**.

 To upload files, go to the Remittance Upload System page of the IOLTA website <u>www.msbf.org/remittanceupload/</u> as shown previously in **instruction a**, and again click the Secure -Remittance Upload red button:



This will bring up RUS:

- Under "Login," click Login.
- Enter your username (email address) and the password you created during the registration process and click on the "I'm not a robot" checkbox. (This is your permanent username and password for the RUS system)
- You are now logged into RUS.

• Choose the type of file to be submitted from the drop-down menu (Remittance File, Adjustment File or Closed Accounts File).

**Remittance File** – This file type contains remittance data for regular monthly or quarterly reporting periods.

- Complete all fields on the form (fields with (\*) will be validated):
  - Beginning and end dates of the period being reported.
  - \*Total number of accounts.
  - \*Total average daily balances of the accounts for the period.
  - \*Gross interest.
  - \*Fees (if applicable).
  - \*Net interest.
- If all IOLTA accounts are paid the same rate, choose the **Single Interest Rate** button and enter the flat rate.
- If tiered rates are paid, choose the **Tiered Interest Rate** button and enter each level of balance and rates.

**Adjustment File** - This file format is identical to the remittance file type but contains remittance data missing or corrected from time periods that have already been reported. Institutions may use the same remittance template as regular remittances.

- The upload process for an **Adjustment File** includes the same required fields as a Remittance File and contains the same selection of **Single Interest Rate** or **Tiered Interest Rate**.
- There is an additional text field labeled **Reason for the Adjustment**. Here, write a brief explanation for the adjustment.

**Closed Accounts File** – This file type contains data of accounts that have been closed during the reporting period.

- The template for the Closed Accounts File form is available at <u>www.msbf.org/remittanceupload/</u> and requires the following content:
  - Column A is the account name,
  - Column B is the account number and,
  - Column C is the closed date (mm/dd/yyyy)
- Select the file you wish to be uploaded from your local directory by clicking the Choose File button and double clicking the file from the appropriate directory once identified.
- After completing the required fields for the file type (**Remittance File**, **Adjustment File**, or **Closed Accounts File**), click Verify.

## c. Validation

To streamline the remittance process, the remittance file you submit will be automatically validated by RUS to ensure its accuracy and integrity.

Certain fields, those denoted above with (\*), will be validated against the contents of the file that was uploaded. The uploaded file will also be evaluated to ensure that fields calculate correctly, that there are no extraneous data in the file, and that the fields are properly formatted (e.g., numbers in number fields).

If a discrepancy is found, RUS will report to you the error and the line of the report that contains the error. You will then have an opportunity to correct the error and resubmit the file.

Once the file is successfully validated, you will receive this message:

File validated, Thank you. Please verify the information entered above and click 'CONFIRM SUBMISSION' to confirm and completeprocessing for this remittance.

Click Confirm Submission and you will receive this message:

File submitted successfully. You may log out or upload another file.

Repeat this process each time you submit a remittance file.
