


# **CIVIL LEGAL AID IN MICHIGAN** 2021 REPORT OF SERVICES

# **CIVIL LEGAL AID OVERVIEW**

The Michigan State Bar Foundation provides funding to regional and statewide legal aid organizations throughout Michigan to assist low-income residents and vulnerable populations.



**AVOIDING FINANCIAL** DISTRESS

A single mother with limited resources was contacted by the Social Security Administration (SSA) about an overpayment and collection which would cause her hardship. Legal Aid determined the best strategy and helped her submit the necessary documents to the SSA. The entire amount of the overpayment was waived.

The funding distributed to legal aid programs helped 112,192 people in households, including 47,140 children



#### LEGAL AID PROVIDES HOPE FOR CLIENTS THROUGH **EXPUNGEMENTS**

A veteran contacted legal aid for help with an expungement of a criminal record. A pro bono attorney was assigned through a legal aid office, and he was diligent in securing the necessary documents to get the client's record expunged. The veteran was able to graduate from nursing school, obtain his license and gain employment.

# CIVIL LEGAL AID PROVIDES CRITICAL CONSTITUENT SERVICES

The Foundation's annual grantees are a lifeline for low-income households to help solve civil legal problems. The programs coordinate services through a statewide infrastructure to provide a continuum of services.



**Michigan Legal Help Program** is an online clearinghouse providing information on legal topics, links to legal forms and other self-help resources. The website also includes a triage and referral function through the *Guide to Legal Help*, a step by step tool connecting people to the right resources, including referrals to attorneys or a legal aid organization.

Counsel and Advocacy Law Line (CALL) is a statewide attorney staffed hotline for low-income individuals and older adults. CALL attorneys advise on housing, public benefits, consumer law, domestic relations, unemployment benefits and other civil matters. CALL provides tailored advice to individuals who call for help and direct referrals to legal aid organizations.

# • In 2021, CALL provided legal advice and referrals for 18,090 closed cases



Nonprofit civil legal aid organizations provide representation when a case is more complex or an attorney is needed. The legal aid programs in Michigan are integrated within their communities and work closely with community partners to identify clients who need help. Legal Aid organizations provide the infrastructure to facilitate pro bono services and in 2021, private attorneys contributed over 16,380 hours of pro bono assistance to clients seeking help from legal aid organizations funded by the Foundation.

# **FUNDING SOURCES**

**Interest on Lawyers' Trust Accounts (IOLTA)** Attorneys are required to hold deposits made on behalf of clients in a trust account and when that amount is short-term or nominal, they pool it into one account. The interest generated by these accounts is remitted to the Foundation to help with grantmaking.

#### **Filing Fees**

MSBF administers filing fee funds for distribution to legal aid programs (MCLA 600.1485).

#### Access to Justice Campaign


A collaborative centralized campaign, in partnership with the State Bar of Michigan, administered by the Foundation, to raise money from the legal community for 15 civil legal aid organizations throughout Michigan.

#### **Special Initiatives**

MSBF receives and manages other funding through state agencies, including federal funding, to help families facing eviction and individuals with disabilities.
